#### CSTHA/AHSTC: ASSOCIATION NEWS

The Executive recently asked the membership to support its stand in withdrawing from PRISMA, the four-society federation, because of recent changes in SSHRCC policy which would be detrimental to the Association. Approximately one-quarter of the members responded, with the referendum vote 97% in favour of the Executive's move. Should government policy shift to a more favourable stance, negotiations with the other three societies could be reopened.

In the meantime, the Association will be represented at a planning session, tentatively to be held in Halifax in April, to explore the possibility of a four-society-sponsored regional conference on science, technology and Atlantic regional history. Niels Jannasch, Director of the Maritime Museum of the Atlantic in Halifax, is the CSTHA/AHSTC representative. A similar conference, oriented towards Western Canada, would be equally attractive; members interested in Western Canadian science and technology are invited to contact members of the Association Executive concerning the future possibility of a co-sponsored regional conference.

Members are reminded that the Third Kingston Conference offers a forum for their research and suggestions for papers and/or sessions are still welcome by the planning committee. Plans are already well advanced and sessions devoted to industrial archaeology, women and technology, science policy, education and museums are scheduled. Titles and brief abstracts should be sent to Dr A.W. Tickner, National Research Council, Ottawa KIA OR6.

#### BABBITT PAPERS TO NRC

The papers of J.D. Babbitt have been placed in the Archives of the National Research Council in Ottawa. Dr Babbitt, a graduate of the University of New Brunswick and a Rhodes Scholar, worked for many years with the Council and was its long-time Secretary for International Relations. Historians will remember him for his edition of E.W.R. Steacie's speeches and for his bibliography of Canadian science policy (see HSTC Bulletin #20, p. 52). ## RESEARCH GRANT TO ENROS

Philip C. Enros has been awarded a two-year SSHRCC research grant, including a twelve-month research time stipend, to study 'Universities and the Development of Industrial Research in Canada, 1900-1939: a Study of McGill, Queen's and Toronto.' Some of the areas upon which he intends to focus include the public position of the universities with respect to industrial research, the place of these views in their goals, the role of their professors, their programmes for educating scientific and engineering personnel and the use of their facilities by

external agencies.

Dr Enros is currently teaching part-time with the Institute for the History and Philosophy of Science and Technology at the University of Toronto.

#### CANADIAN SCIENCE AND TECHNOLOGY BIBLIOGRAPHY PROJECT

Professors Alan Richardson of the University of Western Ontario and Richard Jarrell of York University have been awarded \$51,000 by SSHRCC to undertake the production of a machine-readable bibliography of Canadian science and technology. The grant, awarded under the Strategic Grants--Canadian Research Tools programme, will be devoted primarily to finance the work of research assistants and computer time, beginning on 1 May 1983 and finishing approximately 1 May 1984. The bibliography will include monographs, pamphlets and journal articles from the 17 th century up to the end of 1913 (thus connecting with P. Enros' bio-bibliography of Ontario science and technology, which covers the 1914-1939 period). Materials covered will comprise Canadian-published, Canadian-authored and Canadian-oriented items. The investigators expect that the final bibliography may surpass 10,000 entries.

The bibliography, with bilingual introduction and indices, will be published in two parts, the first listing titles by author, chronologically, the second by subject, also chronologically. Short-title and subject indices are envisioned. The computer data base will be accessible for various bibliometric measurements. The investigators intend to make the bibliography available to scholars in both printed and microfiche editions.

## THE HUGH LECAINE PROJECT

Gayle Young, a Toronto-area composer, has, for several years, worked on a study of Hugh LeCaine, a pioneer in the creation of the electronic synthesizer. LeCaine, a Port Arthur native, worked at the National Research Council from 1940 until 1975. A physics graduate of Queen's, LeCaine's contact with universities resumed with his role in the formation of the Electronic Music Studio at the University of Toronto in 1959. Young's research, supported by a Canada Council Explorations grant, has led to the production of eight newsletters on various aspects of the project, taped interviews and other materials. ## MCGILL-QUEEN'S PRESS

Prof H.T. Wilson (York University) relates that Prof Donald Akenson, Department of History, Queen's University, is a new editor with the revived McGill-Queen's Press and has evinced an interest in manuscripts dealing with the history of Canadian science, technology and industry. Prof Akenson promises that manuscripts will be dealt with with despatch and that relatively quick decisions will be made. This will be welcome news for those who know the high calibre of McGill-Queen's publications and the relatively few publishers willing to look at new manuscripts of an academic nature.

## RECENT REFERENCE WORKS

The Canada Institute for Scientific and Technical Information (CISTI) has recently published two reference works which may interest readers. The 1982 edition of Scientific and Technical Societies of Canada lists over 400 organizations with pertinent information. Also available in French, it may be ordered (NRCC #20870, \$8.00) from the Publications Section, CISTI, National Research Council, Ottawa KIA 0S2.

An index of NRC numbered series publications from 1977-81 is now available as Publications of the National Research Council of Canada Numbered Series 1977-1981 (NRCC #20547, \$28.00). Also available in French, the index includes approximately 5000 of the 20,000 journal articles, reports, proceedings, books and manuals written by NRC staff. The index may be ordered from the Publications Section.

The National Library of Medicine (USA) has published the most recent Bibliography of the History of Medicine (#17, 1981) which includes some 4500 citations, many of Canadian interest. Copies of the bibliography (S/N 017-052-00235-0) are available to Canadians at \$US 9.40 through the Superintendent of Documents, Government Printing Office, Washington, DC 20402, USA.

## CANADIAN SCIENCE AND TECHNOLOGY AT THE LEARNEDS

After last year's bumper crop of papers on Canadian topics read at the Canadian Society for History and Philosophy of Science, the 1983 programme for Vancouver will see just two papers: J.E. Kennedy (Saskatchewan) will speak on 'Instruments used in Surveying Canada,' while David Vogt (British Columbia) will discuss 'Prairie Medicine Wheels: the Pre-historic Astronomy and Geometry of the Northwest Plains Indians.' Both papers will be given on 7 June at the CSHPS meetings on the UBC campus.

## NEW BOOKS FROM HSTC PUBLICATIONS

The first edition (1979) of R.A. Jarrell and A.E.
