David Bercuson is currently at the Centre for Military and Strategic Studies at the University of Calgary. He has written, co-authored or edited over 30 popular and academic books including *Significant Incident: Canada's Army, the Airborne, and the Murder in Somalia*, and *Blood on the Hills: The Canadian Army in the Korean War*.

Craig Heron teaches in the Division of Social Science and Department of History at York University. He is the author of *Working in Steel: The Early Years in Canada, 1883-1935* and *The Canadian Labour Movement: A Short History* and editor of *On the Job: Confronting the Labour Process in Canada* and *The Workers' Revolt in Canada, 1917-1925*. He is currently editor of the Themes in Canadian Social History series and a board member of the Ontario Workers Arts and Heritage Centre.

Marcus Klee is currently enrolled in the final year of the LL.B. program at Osgoode Hall Law School, having completed his PhD in the Department of History at Queen's University in 1998. Marcus has been appointed to a clerkship at the Ontario Court of Appeal.

Kurt Korneski is a Ph.D. candidate at Memorial University of Newfoundland.

Paul LeBlanc is Assistant Professor of History at Carlow College in Pittsburgh, Pennsylvania. He is author of *A Short History of the US Working Class*.

Wayne Lewchuk is Director of Labour Studies and is cross-appointed in the Department of Economics at McMaster University. His research interests include the history of occupational health and safety, and work reorganization and its impact on the quality of life at work. He attended high school in Windsor not far from the Bendix plant on Argyle Road.

Peter McInnis teaches community studies at the University College of Cape Breton, where he had ample opportunity to ponder questions of union leadership during a recent five-week faculty strike.

Tom Mitchell is the archivist at Brandon University and the author of many articles concerning World War I and post-war radicalism. He is currently working on a study of domestic service, seduction, betrayal and murder in late-Victorian Brandon.

James Naylor teaches history at Brandon University and has examined the events of 1919 in Ontario and on the Prairies in Craig Heron, ed., *The Workers' Revolt in Canada, 1917-1925*. His current research explores the fate of Canadian socialism in the 1930s and 1940s.

Peter H. Sawchuk is a researcher with the Centre for the Study of Education and Work (OISE/University of Toronto), and teaches Labour Studies at Brock University and McMaster University.

Robert Storey teaches in the Labour Studies Programme and is Chair of the new MA in Work and Society. He is cross-appointed in the Sociology Department. His present research includes an investigation into asbestos at the Johns-Manville plant in Scarborough — what the 1984 Ontario Royal Commission on Asbestos termed a “world class occupational health disaster.” He is also exploring the “disappearance” of women workers in Canada in health and safety discourse from the 1880s (Factory Acts) to the 1910s (Workmen's Compensation).

Scott Vokey is a migrant teacher, writer, and editor who has been economically exiled from Newfoundland.

Andrew Yarmie teaches history at the University College of the Cariboo. His main research focus has been on employers' associations in Britain and British Columbia. He is currently working on a comparative analysis of Canadian and American employers' associations by developing a case study of industrial relations in British Columbia and Washington state during the early 20th century.
