



## PRESENTATION OF MANUSCRIPTS

### General considerations

- *Revue Gouvernance* does not accept manuscripts **already published or submitted** to other journals.
- The maximum size of articles is limited to **8,000 words** including text, notes, bibliographic references and appendices, but not including abstracts in both languages. The number of words must appear at the end of the article.
- Manuscripts should include **two 250-word summary (in English and French)** and **3 to 6 key words** in both languages.
- Manuscripts should also include **short biographies** of each author of a **maximum of 15 to 20 words each**.
- **All references** cited in the text should appear bibliography.
- Formatting:
  - The paper must be in APA Style and the **font must be Palatino, 12-point size**.
  - The layout of the texts must respect the following criteria:
    - **double-spaced and 2.54 cm margins** on all sides
    - Titles and subtitles must be in **bold** and the text must be divided according to the following guidelines:
      - Introduction (Palatino 16)
      - 1. Title (Palatino 16)
      - 1.1. Subtitle (Palatino 12)
      - 1.2. Subtitle (Palatino 12)

2. Title (Palatino 16)
  - 2.1. Subtitle (Palatino 12)
  - 2.2. Subtitle (Palatino 12)

Conclusion (Palatino 16)

- Tables and figures should be presented as follows and also **sent as an attachment with the manuscript**:

Table X: Title

- Palatino 12pt - centred – underlined - bold
- Table source: Placed under table - Palatino 10pt – justified left - bold

Figure X: Title

- Palatino 12pt - centred – underlined - bold
- Figure source: Placed under table - Palatino 10pt – justified left - bold

- Bibliographic references should be organized in **alphabetical order** starting with the first author's surname or the title if there is no author. Use only the initials of the author's first name, not the first name in full, with a space between the initials.
- **Hanging indents** should be used for the reference list entries. The second line should be indented of at least 1.2 cm or one half inch from the left margin.
- If the reference list includes **two or more entries by the same author(s)**, list them in chronological order (oldest first). If two or more references come from the same author and the same year, list them in alphabetical order, and add a lower case letter (a, b, etc.) after the year in the parentheses.
- **Only journal titles, volume numbers and even the comma following the journal title must be italicized.**

# Citations in Text

When using a direct quotation

- (Hobbs, 2001, p. 1617).

When paraphrasing an idea, the citation will include author(s) and date:

- Author's name given in the body of your paper:
  - Hobbs (2001) reported...
- Author's name not given in the body of your paper:
  - A study of the comparison process (Hobbs, 2001)

For electronic sources without page numbers, use the abbreviation para. If the paragraph number is not apparent, cite the section heading and the paragraph number following it.

- (Buechner, 1976, para. 5)
- (Buechner, 1976, Conclusion, para. 1)

Order two or more works within the same parentheses as they would appear in the reference list.

- Various authors (Buechner, 1976, 2005; Marchand et Jonas, 2002a, 2002b; Martin *et coll.*, 2008) have demonstrated...
