Advance Notice

RESEARCH COMPILATION: RECENT AND PLEISTOCENE SEDIMENTS

A compilation of current and recently completed research work on Recent sediments and all relevant Pleistocene studies in the Atlantic Region will appear in the October issue of MARITIME SEDIMENTS. A format similar to the compilation on Ancient Sediments (pages 88 - 99 of this issue) will be employed, with probably the geographical location as the main indexing factor.

Included in the scope of this work is minor geophysical (sparker, etc.) work where Recent or Pleistocene sediments are under study, submarine topography, geochemical and other experimental work, studies of Pleistocene land forms, deposits and stratigraphy, etc. The region of prime interest is from northern New England waters to the Newfoundland Grand Banks, but we will be interested to hear of anything from Cape Cod to the eastern Canadian Arctic, and from the St. Lawrence and other rivers out to as far as the Mid-Atlantic Ridge.

Response forms for research titles and summaries will be inserted in the July issue of MARITIME SEDIMENTS, and workers are asked to send these back promptly, and by September 1st 1966 if possible. If they expect to be away on field work at that time, we would greatly appreciate it if they would leave details of their work with a colleague, assistant or secretary for them to fill out and return before the deadline.
