A graduate of the University of Western Ontario and Columbia University, he has published essays in nineteenth century Canadian legal history in the *Law and History Review*, *Essays in the History of Canadian Law*, the *Canadian Historical Review* and the *Revue française de théorie juridique*.

Cathy Chorniawry is a doctoral candidate at Cambridge University and is currently working as a research consultant with Historic Sites Service, Alberta Culture.

Philip Corrigan teaches sociological history and applied sociology at the Ontario Institute for Studies in Education. He has recently coauthored *The Great Arch: English State Formation as Cultural Revolution* (Oxford, 1985) with Derek Sayer, and with Derek Sayer and Gerald Aylmer is coorganizer of the Discussion Group on the State at St. Peter's College, Oxford. With Bruce Curtis he codirects the current Canadian "State Formation Project."

Bruce Curtis teaches sociology at Wilfred Laurier University. He has published a number of essays in comparative educational development, the politics of literacy and education as state formation. With Philip Corrigan of OISE he codirects the current Canadian "State Formation Project."

Lyle Dick is a historian of agriculture and prairie settlement with Parks Canada's Prairie Regional Office in Winnipeg. As project historian for the Motherwell Homestead National Historic Park he has produced several research monographs on the social, economic, technological, structural and landscape history of this site. Françoise Noël teaches history at the University of Victoria. Her research is on rural Quebec and seigneurial tenure in the late eighteenth and early nineteenth centuries. She has published an article on seigneurial survey and land granting policies in the Upper Richelieu valley in *Canadian Papers in Rural History*.

Malcolm MacLeod teaches history at Memorial University of Newfoundland, where he is also deputy director in the Office of Research.
