## *Our Contributors/Nos auteurs*

**John Beattie** teaches early modern English history at the University of Toronto, where he has been since 1961. The author of *The English Court in the Reign of George I*, his most recent work, *Crime and the Courts in England, 1660-1800* (Princeton, 1986), has received both the Wallace K. Ferguson Prize of the Canadian Historical Association and the Leo Gershey Award.

**Jacques Paul Couturier** est étudiant au doctorat à l'Université de Montréal. Sa recherche doctorale porte sur la justice civile au Nouveau-Brunswick durant la période 1870-1914. Il a publié des textes sur l'historiographie acadienne et sur la prohibition des boissons alcoolisées dans l'ouvrage collectif *Les Acadiens: état de la recherche* et dans la *Revue de l'Université de Moncton*.

**Ken Cruikshank**, a graduate of Carleton and York universities, currently is completing his doctoral studies at York. His thesis, "The Limits of Regulation: Railway Freight Rate Regulation and the Board of Railway Commissioners, 1850-1929," reflects his broader interest in the history of regulation and the emergence of the modern Canadian state. A previous study, "The People's Railway: The Intercolonial Railway and the Canadian Public Enterprise Experience," appeared in the autumn 1986 issue of *Acadiensis*.

**Olive Patricia Dickason** specializes in Amerindian history in her capacity as professor at the University of Alberta. Her publications include *The Myth of the Savage and the Beginnings of French Colonialism in the Americas* (1984). She is currently coauthoring *The Law of Nations and the New World*, scheduled to appear in the spring of 1988.

**Pierre Gregoire** a effectué sa scolarité de maîtrise à l'Université Laval de Québec et sa recherche à Aix-en-Provence. Il prépare actuellement un D.E.A. sous la direction de M. Philippe Joutard à l'Université d'Aix-Marseille I, alors que sa recherche de doctorat est supervisée à l'Université Laval par Mme Claire Dolan et M. Bogumil Koss-Jewsiewicki. Sa thèse porte, d'une manière générale, sur les aspects symboliques des pestes provinciales par le biais des discours historiographiques, médicaux et littéraires.

**Elly Hermon** a un doctorat en histoire de l'Université Paris-Sorbonne. Il a été affilié en tant que chargé de cours et professeur-chercheur à plusieurs universités au Québec. Il est l'auteur de plusieurs études portant sur divers aspects de l'histoire contemporaine des relations internationales, publiées et en voie de publication dans les ouvrages et des revues spécialisées au Canada, en Europe, et aux Etats-Unis. La présente étude est un des résultats d'un projet subventionné par le Conseil de recherches en sciences humaines du Canada.

**Yvan Lamonde** est professeur d'Histoire à l'Université McGill. Ses volumes et articles ont majoritairement porté sur le problème de la culture urbaine et différents aspects de la culture à Montréal entre 1760 et 1920 et sur l'histoire sociale des idées au Québec de 1760 à 1960.

**Ian MacPherson** is professor of History at the University of Victoria. A graduate of the Universities of Windsor and Western Ontario, he has focused on the history of the cooperative movement in Canada. He is the author of, among other books, *The Story of CIS Ltd.* (1974), *A very special trust company: a history of the first 25 years of Co-operative Trust Company of Canada* (1978), *Each for all: a history of the co-operative movement in English Canada, 1900-1945* (1979), *Matters of Loyalty: the Buells of Brockville 1830-1850* (1981), and *Building and protecting the co-operative movement: a brief history of the Cooperative Union of Canada* (1984).

**Paul Merkley** is professor of History at Carleton University. His published books include *Reinhold Neibuhr: A Political Account* (1975) and *The Greek and Hebrew Origins of Our Theory of History* (1987). His teaching speciality is American political and religious history, and he has recently published articles in the theory of history and Christian theology.

**Christine Métayer** prépare un doctorat en histoire à l'Université Laval sous la direction de Claire Dolan et, cette année, réalise un D.E.A. à l'Ecole des Hautes Études en Sciences sociales à Paris avec Roger Chartier. Ses recherches portent sur les écrivains publics et les milieux populaires parisiens sous l'ancien régime.

**Diane Newell** is associate professor of History at the University of British Columbia. She is author of *Technology on the Frontier: Mining in Old Ontario* (1986) and of several articles on industrial history and archaeology which have appeared in journals as diverse as the *Journal of Historical Geography*, *Technology and Culture* and *World Archaeology*. She is currently writing a book dealing with the socioeconomic aspects of the Pacific salmon canning industry and another, with Ralph Greenhill, on Canada's industrial archaeology.

**Ronald Rudin** is an associate professor of History at Concordia University. He is the author of a number of publications on the social and economic history of Quebec including *Banking en français: The French Banks of Quebec, 1835-1925* and *The Forgotten Quebecers: A History of English-Speaking Quebec, 1759-1980*.
