**Alan G. Arthur** teaches history at Brock University and has focused his research on popular culture and peasant society in early modern France. He plans further research on regional religious patterns in northern France before proceeding to a wider study of literacy, religion and the notions of “high” and “low” culture.

**Michael Cross** is Associate Dean of Arts and Science, and a member of the Department of History, at Dalhousie University. His primary research interest has been the study of violence in 19th century Canada.

**Gordon Darroch** teaches sociology at York University and is currently Director of York’s Institute for Behavioural Research. He is currently working on a study of households, class and mobility in central Ontario in the 19th century, with Michael Ornstein. He has published articles on 19th century social history in the *Canadian Historical Review*, *The Journal of Family History*, *Labour/Le Travailleur* and *Histoire sociale/Social History*.

**Jean-Louis Flandrin** est professeur d’Histoire moderne à l’Université de Paris 8-Vincennes, et directeur d’Etudes à l’EHESS. Historien des sensibilités et des comportements, il a travaillé d’abord sur le comportement amoureux puis sur la sensibilité alimentaire. Ses principaux ouvrages sont *L’Eglise et le contrôle des naissances* (1970), *Les Amours paysannes* (1975), *Familles* (1976), *Le Sexe et l’Occident* (1981), *Un Temps pour embrasser* (1983) et *Le Cuisinier français* (1983).

**David Frank** teaches history at the University of New Brunswick, where he is also editor of *Acadiensis: Journal of the History of the Atlantic Region*. A graduate of Dalhousie University and the University of Toronto, he has published studies on the economic and social history of Atlantic Canada in *Acadiensis*, *Histoire sociale/Social History* and *Labour/Le Travailleur*. His current work includes a biographical study of J.B. McLachlan.

A graduate of the University of Toronto, **Robert Fraser** is currently with the *Dictionary of Canadian Biography*. His research has focused on law and society in 19th century Upper Canada/Ontario.

**Bernard Lightman** is Assistant Professor of Honors College History at the University of Oregon. During the past several years he has published articles on J. S. Mill's philosophy of nature, the Victorian Broad Church and agnostic epistemology. He is coauthor of a forthcoming bibliography of secondary sources on science and religion in Victorian England. Recently he completed a book-length study of the origins of agnosticism.

**Michael Ornstein** is Associate Professor of Sociology and Associate Director of the Institute for Behavioural Research at York University. His current research interests include class and the family in 19th century Canada, interlocking directorates of large corporations in the post-war period, and the political ideology of corporate élites, state élites and the public in contemporary Canada.

**David Pratt** teaches in the Faculty of Education at Queen's University. He has written extensively on curriculum planning, textbook analysis and the teaching of history. His major current interest is the integration of technical and humanistic approaches to curriculum.

**James Struthers** is an Associate Professor in the Canadian Studies Programme at Trent University. He is the author of *No Fault of Their Own: Unemployment and the Canadian Welfare State, 1914-1941* and has published articles in the *Canadian Historical Review* and the *Journal of Canadian Studies*. At present he is studying the development of Canadian social work in this century.

**Tom Traves** is Dean of Arts at York University and author of *The State and Enterprise: Canadian Manufacturers and the Federal Government, 1917-1931*.

**David Wootton** teaches history at Dalhousie University. He has previously taught in the universities of London (England) and McGill. He has recently published a book on Paulo Sarpi which is a study in early modern opposition to Christianity. He is currently working on the English Civil War and is editing a selection of 17th century English political thought texts.
