**Judith A. Allen** is chair of Women's Studies at Griffith University in Brisbane, Australia. She is author of *Sex and Secrets: Crimes Involving Australian Women Since 1860* (1990) and *Rose Scott: Vision and Revision in Australian Feminism 1880-1925* (forthcoming). She is currently working on a historical study of population changes and the sexes comparing Canada, the United States, New Zealand, and Australia during the period between roughly 1860 and 1960.

**Peter Bischoff** s'intéresse principalement au monde ouvrier de l'Ontario et du Québec du XIX<sup>e</sup> siècle. Ses recherches de maîtrise (Université du Québec à Montréal, 1986) et doctorales (Université de Montréal) ont porté sur ce sujet. **Naomi Black** is professor of Political Science at York University. Coauthor (with Alison Prentice, Paula Bourne, Gail Cuthbert Brandt, Beth Light, and Wendy Mitchinson) of *Canadian Women: A History* (Toronto, 1988) and author of *Social Feminism* (Ithaca, 1989), she is currently working on a study of the contemporary Canadian women's movement.

**Gail Cuthbert Brandt** is associate professor of History at Glendon College, York University. Coauthor (with Alison Prentice, Paula Bourne, Beth Light, Wendy Mitchinson, and Naomi Black) of *Canadian Women: A History* (Toronto, 1988), she is currently completing *Through the Mill: Women in the Quebec Textile Industry 1890-1950*.

**Valerie Burton** joined the staff of Memorial University of Newfoundland in 1989 after a research and teaching career in British universities. She has edited a collection of essays on the port of Liverpool and published articles on seafaring history. She is an editor of the *International Journal of Maritime History*.

**Mark Cox** is an SSHRCC Postdoctoral Fellow at the University of Victoria. The author of several articles on early-twentieth-century regulatory change, he has completed the revision of his thesis for publication and is currently working on a monograph on the development of the regulatory state in British Columbia.

**Brett Fairbairn** is an assistant professor of History at the University of Saskatchewan. His interests include democracy and popular movements in Germany, and cooperative movements in Germany, Canada, and around the world. He has published various articles and chapters on these subjects, as well as a book on consumer cooperatives in western Canada.

**David Gagan** is professor of History and Dean of Humanities at McMaster University, Hamilton, Ontario. His publications include *The Denison Family of Toronto* (Toronto, 1973), *Hopeful Travellers: Families, Land and Social Change in Mid-Victorian Peel*
