## Our Contributors/*Nos auteurs*

**Barbara Angel** is currently a Ph.D. candidate in Latin American history at the University of Manitoba. She has written articles on Canadian fur trade and aboriginal history, as well as her current research on the Mayan Rebellion in nineteenth century Yucatán.

**Jennifer S.H. Brown** is professor of history at the University of Winnipeg. Author of *Strangers in Blood: Fur Trade Company Families in Indian country* (1980) and several other works, she has published widely on fur trade social history and on Metis and subarctic Algonquian ethnohistory, as well as in the fields of documentary editing and Native biography.

**Phillip Buckner** was born in Toronto and received his B.A. from the University of Toronto in 1965 and his Ph.D. from the University of London in 1969. In 1968 he joined the history department at the University of New Brunswick. He has published extensively in the area of Anglo-Canadian relations in the nineteenth century, including a book on *The Transition to Responsible Government: British Policy in British North America, 1815-1850* and innumerable studies of various colonial administrators and an introductory essay for the *Dictionary of Canadian Biography*. He was also the founding editor of *Acadiensis: Journal of the History of the Atlantic Region* and the creator of Acadiensis Press and has published a number of articles dealing with the history and historiography of the Maritimes. He is the co-editor, with John Reid, of the forthcoming *The Atlantic Region to Confederation: A History*. He was also the editor of the first series of CHA booklets on "Canada's Ethnic Groups."

**Sara Z. Burke** is a post-doctoral student at The University of Waterloo.

**Sean Cadigan** currently teaches Canadian economic and Newfoundland history at Memorial University of Newfoundland. He is now finishing research on an economic and social history of St. John's between 1775 and 1855.

**Alvin Finkel** is Professor of History at Athabasca University. He is the author of *Business and Social Reform in the Thirties* (1979) and *The Social Credit Phenomenon in Alberta* (1989) and co-author of the two-volume *History of the Canadian Peoples* (1993).

**Jacqueline Holler** is a doctoral candidate in the history department of Emory University in Atlanta, Georgia, where she studies colonial Spanish American history under Professors Peter Bakewell and Susan Socolow. She holds a Master's degree from Simon Fraser University. The current paper is drawn from research undertaken there under the guidance of Professor Richard Boyer.

**Royden Loewen** teaches Canadian history at the University of Manitoba. His field of research is the rural immigrant experience in comparative perspective. He is the author of *Family, Church and Market: A Mennonite Community in the Old and the New Worlds, 1850-1930* (Toronto, 1993).

**Maureen Matthews** is a freelance radio journalist in Winnipeg. Her CBC Ideas program, "Isinamowin: The Whiteman's Indian," won the 1993 national award from the Canadian Association of Journalists for best investigative reporting (all categories). She also created "The Search for Fair Wind's Drum" (CBC, Ideas, May 1993) in collaboration with Jennifer S.H. Brown, and an Ojibwa-language version of that program in collaboration with Roger Roulette. The Fair Wind program won the 1994 award from the Canadian Association of Journalists for best radio documentary.

Diplômée de l'École des Hautes études en sciences sociales et de l'Université Laval, **Christine Métayer** est professeure à l'Université de Sherbrooke. Auteure de plusieurs articles sur les maîtres écrivains et les écrivains publics à Paris, aux 17e-18e siècles (*Annales E.S.C.*, *Histoire sociale*, *Communications historiques*), elle travaille présentement sur la sociabilité populaire des places marchandes dans la France urbaine d'Ancien Régime (Paris, Toulouse, Montpellier).
