## **Our Contributors/*Nos auteurs***

**Jerry Bannister** is a PhD student in history and a junior fellow at the Centre of Criminology in the University of Toronto. He is currently studying crime and justice in eighteenth-century Newfoundland.

**John Douglas Belshaw** teaches history at the University College of the Cariboo. He has published several articles on British miners on Vancouver Island and has recently completed a monograph on the subject. He is currently working on a book-length study of British Columbian population history.

**Robin Brownlie** is a doctoral candidate in Canadian history at the University of Toronto and is currently writing her thesis, an investigation of two Indian agents in the Georgian Bay area from 1921 to 1939. The thesis explores the agents' application of federal Indian policy, their effects on aboriginal people, and the relations of power among the Department of Indian Affairs, Indian agents, and First Nations.

**Claire Dolan** est professeure à l'Université Laval (Québec). Elle a publié sur l'histoire sociale de la Provence au XVI<sup>e</sup> siècle, sur l'identité urbaine et sur l'histoire des solidarités familiales. Elle travaille actuellement sur la diffusion de la culture juridique en France au XVI<sup>e</sup> et au XVII<sup>e</sup> siècle et s'intéresse particulièrement aux auxiliaires de la justice.

**Gerhard J. Ens** is an Assistant Professor of History at Brandon University. He has published on fur trade and Metis history, and is presently working on a history of Metis merchant families in the nineteenth century.

**Chris Hull** is a doctoral candidate in the history of international relations in the History Department at the University of Toronto. He is currently completing a dissertation on the place of the army in British society between the two world wars.

**Susan J. Johnston** is a PhD candidate in Canadian history at the University of Victoria. She is currently completing her dissertation on cultural responses to sudden death in nineteenth-century British Columbia.

**John Manley** teaches Canadian and United States History at the University of Central Lancashire, Preston. He is currently revising his Dalhousie Ph.D dissertation on the Workers Unity League for publication.

**Cecilia Morgan** is presently revising her doctoral dissertation, "Languages of Gender in Upper Canadian Religion and Politics, 1791-1850," for publication by University of Toronto Press. She has written on women, gender and religion in nineteenth-century Ontario and on gender and the state in British North America. She and Dr. Colin Coates are co-authoring a study of Secord and Madeleine de Verchères as two significant female symbols of Canadian national identity.

**Barry Potyondi** is founder and principal of Great Plains Research Consultants, a Calgary-based public history firm. Since 1977 he has conducted research into many aspects of western and northern history. He is the author of *A Guide to Manitoba Local History* (with Gerald Friesen), *From Wood Mountain to the Whitemud* (with D. M. Loveridge), *Selkirk: The First Hundred Years*, *Where the Rivers Meet: A History of the Upper Oldman River Basin to 1939*, and the forthcoming *Possessing the Land: Ecology and Production in Southwestern Saskatchewan, 1860-1930*, on which this paper is based.

**Veronica Strong-Boag** received her B.A. from Toronto in 1970, her M.A. from Carleton in 1971, and her Ph.D. from Toronto in 1975, all in history. She has taught at Trent, Concordia, Simon Fraser, and the University of British Columbia, where she is currently Director of the Centre for Research in Women's Studies and Gender Relations and Professor of Educational Studies. She has numerous publications in Canadian history, including *The Parliament of Women: The National Council of Women of Canada 1893-1929* (1976), *A Woman with a Purpose: The Diaries of Elizabeth Shortt* (1980), *Rethinking Canada. The Promise of Women's History* (1986, 1991) with Anita Clair Fellman, *The New Day Recalled: Lives of Girls and Women in English Canada 1919-1939* (1988), *British Columbia Reconsidered: Essays on Women in B.C.* (1992) with Gillian Creese, *A History of the Canadian Peoples*, v. 2 (1993) with Margaret Conrad and Alvin Finkel, and "*Janey Canuck*": *Women in Canada Between Two World Wars. 1919-1939* (1994). *The New Day* won the John A. Macdonald Prize from the C.H.A. for the best book in Canadian History in 1988.

**David A. Sutherland** is an associate professor in the Department of History at Dalhousie University. His published work focuses on the history of nineteenth-century Halifax, Nova Scotia.

**Larissa Taylor** is Assistant Professor of History at Colby College. She is the author of *Soldiers of Christ: Preaching in Late Medieval and Reformation France* (Oxford University Press, 1992), as well as numerous articles and book reviews. She is currently working on three projects: a book on preachers and prostitutes in medieval and early modern Europe, a biography of Francois LePicart, and a collaborative study on "Medieval Civilization in Comparative Perspective: China and France."
