His articles have appeared in a wide range of publications, among them the *Canadian Historical Review*, *Ontario History*, *Journal of Canadian Studies*, *Dalhousie Review*, *NeWest Review*, *Prairie Forum*, *Canadian Journal of Native Education*, and *Scholarly Publishing*.

G rard Bouchard is the Director of the Institut universitaire de recherches sur les populations, based at l'Universit  du Qu bec   Chicoutimi. His recent book, *Quelques arpents d'Am rique : Population,  conomie, famille au Saguenay, 1838-1971*, won the John A. Macdonald Prize of the Canadian Historical Association in 1997.

Gordon DesBrisay is an Associate Professor of History at the University of Saskatchewan. He specialises in early modern social, urban, and women's history, and is working on a study of seventeenth-century Aberdeen.
