# INTRODUCTION

Les huit prochains articles sont un choix de communications présentées au Premier séminaire national sur l'interprétation et la traduction qui s'est tenu à Brisbane en Australie.

This is a collection of articles chosen from the papers presented at the *First National Workshop on Interpretation and Translation (I/T)* held in Brisbane, Australia. The workshop was convened by the Key Centre for Asian Languages and Studies at The University of Queensland.

The demographic description of Australia can be compared to that of Canada as it has a significant percentage of non-Anglo-Saxons in its population. There are approximately 16 million people in Australia. Of this number, 13.6% of Australians over 5 years old use a language other than English at home (Clyne 1988). Furthermore, Lo Bianco (1987) listed 1.6 million Australians as non-English speakers by mother tongue.

Apart from the multitude of Aboriginal languages, some of the major LOTE languages spoken in Australia are Italian, Greek, Serbian and Croatian, Chinese and Arabic. The number of speakers of these and other languages are shown in the table below. (Table 1 is adapted from Clyne 1988).

Australia's multicultural make-up is evident from Table 1. In fact, Melbourne is reputed to have the largest Greek population outside of Athens.

Given such linguistic diversity, it is not surprising that issues of inter-language transfer and contact have featured prominently in the Australian sociolinguistic context. However, it is only in recent years that I/T has emerged as a research discipline. This is due more to individual researchers working in isolation rather than a lack of interest, as I/T issues are clearly significant to a multi-cultural country like Australia.

Apart from promoting I/T as a national social interest, recent acceleration in economic ties with Asia have also called attention to the need to train and provide individuals with competent I/T skills in Asian languages of importance to Australia's trade and economic relations.

The University of Queensland has been running a Master's course in Japanese conference interpreting and translation since 1980, and this is a major reason why, since its inception in 1988, the Key Centre for Asian Languages and Studies has made the encouragement of I/T research one of its top priorities. The objective of the I/T in workshop in February 1990 was to bring together researchers working on related topics of I/T. The workshop identified several areas in I/T research which require more "urgent" attention. These are:

- research on user attitudes to I/T and to interpreters and translators
- research on assessment standards and procedures
- research on cognitive issues in I/T
- research on curriculum development in I/T
- research on the socio-economics of I/T in the Australian community
- development of datasets for use in the research
- comparative language studies as impacting on I/T

Currently, there is a team of researchers at The University of Queensland working on different aspects of I/T issues in Japanese and Mandarin Chinese. We hope to extend these studies to other languages such as Korean, Indonesian and Vietnamese. In the light of the present research climate, I/T research will stand to benefit from more cross-linguistic input from typologically different languages. We hope that the present collection will generate more response to I/T research and will encourage greater contact between I/T researchers in Australia and elsewhere.
