JACQUES PAUL COUTURIER received his B.A. from the Université de Moncton and his M.A. from the Université de Montréal where he is currently completing his Ph.D. on the topic of civil justice in Acadian society in the second half of the 19th century. A graduate student in sociology at Carleton, RON CRAWLEY was born and raised in Sydney to which all four of his grandparents emigrated from Conception Bay between 1904 and 1917. INGEBORG MARSHALL, a graduate of Memorial University of Newfoundland and an Honorary Research Associate with the Institute of Social and Economic Research there, is currently engaged in an ethnohistorical investigation of the Newfoundland Beothuck. A member of the Department of Sociology at McMaster University, RALPH MATTHEWS has published extensively on the history of Newfoundland and the Atlantic fisheries and is best known for his book on The Creation of Regional Dependency, CHERYL KRASNICK WARSH recently completed her Ph.D. for Queen's University and is currently preparing her thesis for publication by McGill-Queen's University Press. A frequent contributor to this journal and the author of numerous articles on the history of the French North American Fisheries in the 18th century, JEAN-FRANCOIS BRIÈRE has a Ph.D. in history from York University and is an Associate Professor in the Department of French Studies at the State University of New York at Albany. NEIL MACKINNON, another Queen's graduate, teaches at St. Francis Xavier University and is the author of The Unfriendly Soil: The Loyalist Experience in Nova Scotia, 1783-1791. After teaching at Michigan State, Western Reserve and the University of Michigan, JACK P. GREENE went to The John Hopkins University where he is the Andrew W. Mellon Professor in the Humanities. The author of an enormous number of books and articles on colonial America, he has just completed a book on Pursuits of Happiness: Social Development in the Early Modern British Colonies and is presently writing one on Paradise Defined: Studies in the Changing Character of Corporate Identity in British Plantation America, 1697-1820. A graduate of the University of London, ELIZABETH R. EPPERLY is an Associate Professor of English at Memorial University of Newfoundland and co-editor of My Dear Mr. M: Selected Letters of L.M. Montgomery to G.B. MacMillan and is currently preparing a full-length critical study of Montgomery's novels. A member of the history department at Saint Mary's University, COLIN HOWELL is currently a co-editor of the Canadian Historical Review. CARMAN MILLER received his Ph.D. in history from the University of London and teaches at McGill University; he is the author of a number of books and articles dealing with Anglo-Canadian relations in the early 20th century, R.A. RUTHERDALE is currently working towards his Ph.D. at York University, MAUREEN MALLOY is a member of the sociology department of the University of Auckland in New Zealand.
