DANIEL THORP teaches history at Virginia Polytechnic Institute and State University. The author of *The Moravian Community in Colonial North Carolina* (1989), he has also written numerous articles on the southern colonial frontier of Anglo-America. **GEOFFREY PLANK** is a member of the History Department at the University of Cincinnati. His current research concerns "The Culture of Conquest: Acadia or Nova Scotia in the British Colonial Imagination, 1690-1759". **NICOLE LANG** est professeure d'histoire au campus d'Edmundston de l'Université de Moncton. Ses recherches portent principalement sur l'histoire récente des travailleurs et du syndicalisme au Nouveau-Brunswick. **MARILYN GERRIETS** has published articles on the rise and fall of the General Mining Association of Nova Scotia in *Business History* and in *Acadiensis*. His current research focuses on the history of agricultural journalism in the Atlantic region. **DANIEL VICKERS** is also a member of the History Department at Memorial University. His book, *Farmers and Fishermen: Two Centuries of Work in Essex County, Massachusetts, 1630-1850* (1994) was awarded the AHA Dunning Prize. **PETER RUSSELL** is the author of "*Here we are Laird ourselves*": *Popular Attitudes to Social Structure and Social Mobility in Upper Canada* (1990). He teaches history and economics at Okanagan University College. Professor of history at the University of New Brunswick, **PHILLIP BUCKNER** is well known to readers of this journal.
