Gordon Darroch teaches sociology at York University, and is Director of York's Institute for Social Research. He is currently working on a study of households, class and mobility in central Ontario in the 19th century, with Michael Ornstein. He has published articles on 19th century social history in the *Canadian Historical Review*, the *Journal of Family History*, *Labour/Le Travailleur* and *Histoire sociale/Social History*.

Responsable de l'ERA.098 du CNRD et co-Directeur du Centre de Recherches en Histoire Quantitative (CRHQ) de l'Université de Caen, **Gabriel Désert** est aussi Directeur des "*Annales de Normandie*" et membre du Comité des Travaux Historiques et Scientifiques, section d'Histoire moderne et contemporaine. L'auteur du livre *Une Société rurale au XIX^e siècle, Les Paysans du Calvados, 1815-1895* (1977), il devient Assistant à l'Université de Caen en 1962, et il y est maintenant professeur d'Histoire Contemporaine.

Claude Desrosiers est candidat pour la doctorat à Université de Montréal.

Roger L. Emerson is Professor of History at the University of Western Ontario. He has published a number of essays on Scottish Enlightenment topics, including several recent papers dealing with the Philosophical Society of Edinburgh between 1736 and 1783. He is currently working on a study of the Scottish professoriate between 1690 and 1800.

John Hilliker is a historian with the Historical Division of the Department of External Affairs. He is editor of *Documents in Canadian External Relations*, volumes 9 (1980), 10 and 11 (forthcoming), and the author of several articles on Canadian foreign policy.

Peter C. Kent teaches history at the University of New Brunswick, where he is currently chairman of the Department of History. A graduate of UNB and the University of London, he is the author of *The Pope and the Duce: The International Impact of the Lateran Agreements* (1981). His current research deals with Catholicism and the origins of the cold war.

Andrée Lévesque is a specialist in the history of women as well as of Quebec and Canada in the 20th century. She is the author of *Virage à gauche interdit: les communistes, les socialistes et leurs ennemis au Québec, 1929-1939* and of articles published in *Women's Studies International Quarterly* and the *Revue d'histoire de l'Amérique française*. She has also coauthored *Norman Bethune, son époque et son message*. She is currently working on a history of Quebec women between the two world wars.

Michael Orstein is Associate Professor of Sociology and Associate Director of the Institute for Social Research at York University. His current research interests include 19th century Canadian class and family structure, the structure and ideology of Canadian elites, and contemporary political ideology.
