Kerry Abel is a SSHRCC postdoctoral fellow at the University of Manitoba and at present is researching a history of the Dene. Her doctoral dissertation, "The Drum and the Cross: An Ethnohistorical Study of Mission Work among the Dene, 1858–1902" was completed recently for Queen's University.

Donald Avery teaches history at the University of Western Ontario. He is the author of 'Dangerous Foreigners': European Immigrant Workers and Labour Radicalism in Canada, 1896–1932 and a number of articles on Canadian immigration, ethnic, and labour history.

Gail G. Campbell is currently assistant professor of History at St. Thomas University in Fredericton. A graduate of the University of Western Ontario and Clark University, she studies the participation of ordinary people in the political process. Her article on voter turnout in nineteenth-century southwestern Ontario will appear in a forthcoming issue of *Social Science History*.

Carole Fink, professor of History at the University of North Carolina at Wilmington and a 1986-87 fellow at the Woodrow Wilson International Centre for Scholars in Washington, DC, is the author of *The Genoa Conference: European Diplomacy 1921-22*, which won the George Louis Beer Prize of the American Historical Association in 1985. She has coedited *German Nationalism and the European Response, 1890-1945*; translated and written the introduction to Marc Bloch's *Memoirs of War, 1914-15*, and published several articles on twentieth-century politics and diplomacy.

Philip Goldring studied British Imperial history at Dalhousie University and the University of London. He has been employed since 1969 as a historian by the National Historic Parks and Sites Directorate, Environment Canada – Parks. Most of his published articles and unpublished reports deal with the Canadian north and west before 1900.

Steve Hochstadt shares with Elizabeth H. Tobin a position as assistant professor of modern European history at Bates College in Maine. He has published articles on mobility in Germany in Social Science History in 1981, Central European History in 1983 and Historical Social Research/Historische Sozialforschung in 1984. He is currently writing a monograph on the history of migration in Germany over the past two centuries.

Kris E. Inwood is an assistant professor in the Department of Economics of the University of Guelph. His recent publications include *The Canadian Charcoal Iron Industry: 1870–1914* (New York, 1986); "Productivity Change in Obsolescence: Charcoal Iron Revisited," in the June 1985 issue of the *Journal of Economic*

Sally Marks, professor of History at Rhode Island College, holds a doctorate in international history from the University of London. In addition to numerous articles, she has published *The Illusion of Peace: International Relations in Europe, 1918-1933* and *Innocents Abroad: Belgium at the Paris Peace Conference of 1919*, which won the American Historical Association's George Louis Beer Prize in international history in 1981 and the Phi Alpha Theta award in 1983.

David Monod is a graduate student at the University of Toronto. His PhD thesis deals with the opposition of small businessmen to mass retailing in the interwar years.

James Naylor is currently completing a doctoral dissertation at York University on class conflict in the industrial cities of southern Ontario during and after the First World War.

Michael D. Sibalis, a graduate of McGill University and Concordia University, has taught as a sessional lecturer at eight Canadian universities. He is currently at Brock University. He is writing a book on the Parisian labour movement from 1789 to 1834.
