Preface/Préface

As part of its agreement in late 1985 with *Urbanism Past and Present*, the *Urban History Review* now publishes a bibliography of publications in international urban history in each June issue. The bibliography of Canadian urban history will continue to appear in each October issue of the *Urban History Review*.

The International Urban Bibliography is designed primarily for North American readers. Because of space limitations it must be selective, including books and major articles rather than purely local histories or case studies. In accordance with Canada's official language policy, mainly English and French-language publications will be listed. References to publications in other languages should be highly significant statements, for which translated titles should also be provided.

The bibliography is organized first in a general part, subdivided into historiographical, economic, demographic/social, environmental/physical, and administrative sections. The larger Regional division has sections on each world region, subdivided by individual countries. This year, for the first time, the major section on the United States is subdivided both topically and by major cities.

In compiling this second international listing, I thank publishers in the field of urbanism and urban history who sent notice of new books. The contributions of the following are appreciated: David Buck, Bruce Fetter and others of the

En raison de l'entente survenue à la fin de l'année 1985 avec *Urbanism Past and Present*, la *Revue d'histoire urbaine* publiera désormais une bibliographie internationale des publications en histoire urbaine dans le numéro de juin. La bibliographie des publications récentes en histoire du Canada urbain continuera de paraître annuellement dans le numéro d'octobre de la *Revue d'histoire urbaine*.

La bibliographie internationale du monde urbain est surtout destinée aux lecteurs nord-américains. A cause des restrictions d'espace, elle se doit d'être sélective, incluant livres et articles majeurs plutôt que des histoires purement locales ou des études de cas. En conformité avec la politique canadienne sur les langues officielles, les publications rédigées en anglais et en français seront principalement répertoriées. En ce qui concerne les publications dans les autres langues, elles seront largement traitées et les titres seront également traduits.

La bibliographie comporte une première grande division intitulée Aspects généraux, subdivisée en plusieurs sections: historiographie, économie, démographie et société, environnement et aspects physiques et finalement administration. La seconde division, plus vaste, s'intitule Régions et se subdivise à son tour selon les divers pays. Cette année, pour la première fois, la section majeure sur les États-Unis est sous-divisée en sections selon les sujets et les villes majeures.

Dans le cadre de cette deuxième compilation, je remercie les éditeurs oeuvrant dans le domaine de l'urbanisme et de
